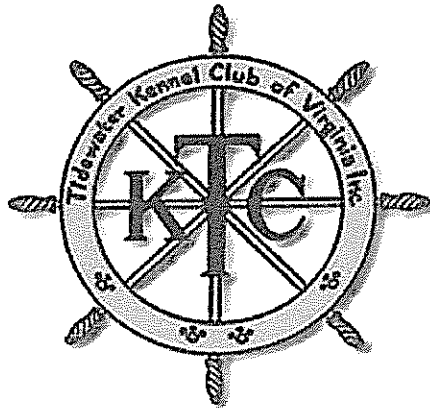

If taking Witchduck Road exit off of either Virginia Beach Boulevard or I-264, Lobaugh Drive will be on the left approximately 2.3 miles.

If coming off of I-64, you will take Exit 286B Indian River Road/VA 407 1.2 miles, then left onto VA-190 Kempsville Road for 1.4 miles, then right on Lobaugh Drive.
